BIDDER hereby agrees to commence WORK under this contract on or before a date to be specified in the NOTICE TO PROCEED and to fully complete the PROJECT within forty (45) consecutive calendar days thereafter. BIDDER further agrees to pay as liquidated damages, the sum of two hundred fifty dollars (\$250) for each consecutive calendar day thereafter as provided in Section 15 of the General Conditions.
